- 1) The specific conditions of use as mentioned in IECEx ETL 22.0061X Issue No-0, dated 23/03/2023 shall be communicated to the end user and same to be followed strictly.
- 2) The device shall not be opened inside the hazardous area while it is powered on for the purposes of repair or testing. You are instructed to specify the same to end user.
- 3) Only PESO approved cable entry gland / sealing plug shall be used in flameproof enclosure housing. You are instructed to specify the same to end user.
- 4) Approval shall be valid till any change in the product standard or change in the design of product and the manufacturer shall obtain subsequent approval for the Ex Electrical Apparatus in case of revision in product standard (other than base standard i.e. 60079-0: General Requirement) or change in the product design.

This approval also covers the permissible variations as approved under the Intertek test reports referred above. This approval is liable to be cancelled if any of the conditions of the approval is violated or not complied with . The approval may also be amended or withdrawn at any time, if considered necessary in the interest of safety.
